INSTITUTE FOR ORAL HEALTH

The purpose of the ADHA Institute is to raise funds in order to provide both scholarships and grants to dental hygiene students, educators, and practitioners. Award Amount: \$1,000

The applications for these scholarships become available on Oct 1 and are found on the ADHA/IOH/Scholarship website. The deadline to turn in the application is February 1 so there is still plenty of time. If you are enrolled in a MS program, please take advantage of this opportunity!
