Scientific Session Is Sooner Than You Think

We are excited to present another fun, informative program March 18 to 20, 2016. We have nationally known speakers and that is the best there is! You will be able to get 17 hours of credit as well.

Friday will have Cal Whitehead, VDHA lobbyist, discussing legislative issues pertaining to our profession. In addition, Melanie Swain, RDH, BSDH, VDHA member and immediate past president of the Virginia Board of Dentistry, will review the new regulations that have been implemented along with Board of Dentistry executive director, Sandra Reen.

Jane McGinley, RDH, MBA is a representative from the American Dental Association and will cover the importance of fluoridation for the population. There has been some controversy about fluoridating the water in different areas and she will present facts in support of fluoridation.

In the afternoon, we will present an overview of the interprofessional team concept in the care of patients. There are different areas that interlock with treatment. Virginia Dental Hygienists' Association Storms the Capitol at its Annual Rally Day January 29th in Richmond, Virginia



The snowstorm of mid-January did not stop the Virginia Dental Hygienists' Association from advocating for our profession. The Virginia Dental Hygienists' Association was back in action at the Capitol this year. The members of the association advocated for the passage of Senate Bill 712 (SB 712), which, if passed, will expand remote supervision for dental hygiene.

Representatives of the Virginia Dental Hygienists' Association (VDHA) and the Virginia Dental Association (VDA) have worked together over the past year to develop a bill that will expand remote supervision of licensed dental hygienists to new settings to serve more patients through direct access. Remote supervision of dental hygienists employed by the Virginia Department of Health both as a pilot study and ongoing program has proven to be a highly successful model in improving access to care and cost savings.

VDHA will continue to advocate for expansion of the Remote Supervision Public Health Model for the dental hygienist employed outside of the Virginia Department of Health so that all patients have direct access for care by the dental hygienist and can receive necessary referrals to a dentist. Enabling dental hygienists to practice as an employee and/or volunteer with a supervising dentist for both general and remote supervision will immediately better serve the needs of Virginians residing in Dental Health Professional Shortage Areas (DHPSA). This year's Rally Day had attendance that was greater than last year with a grand total of 212 Dental Hygienists! Dental Hygiene schools represented this year were: Virginia Commonwealth University, Old Dominion University, Northern VA Community College, Germanna Community College, Thomas Nelson Community College, Lord Fairfax Community College, and Virginia Western Community College (*pictured below*).



Many Dental Hygienists and faculty members took time out of their busy work and school schedules to display support for our organization. Students were able to learn a great deal about the legislative process and meet with their legislators. They also learned how important it is to share information throughout the state that oral health is connected to total health and to advocate for the Dental Hygiene profession.

We would like to thank everyone who worked toward and dedicated his or her time to make this year's Rally Day a success. VDHA would also like to thank our wonderful Lobbyist and his firm: Cal Whitehead for all his and his team's hard work and time dedicated to our professional organization. We are all geared up and excited to make next year's Rally Day even more successful!
