April Rodgers, OMG's Executive Director been training components how to utilize the features of our website.

We are closely watching HB793 introduced by the Virginia Council of Nurse Practitioners. "The legislation is drafted in a way that would permanently end, after a designated period of post licensure practice hours, the current requirement for a NP to have a "practice agreement" with a designated physician, which has been shown to adversely impact patient access to care and eliminate NP jobs, in some cases. This practice agreement is now required for the duration of the NPs career, which is one of the reasons why Virginia is considered as having one of the most restrictive practice statutes in the country, needing to be modernized."

Please join us at Scientific Session in Richmond on March 23-25. You can earn 17 CEs and meet and listen to Mary Otto, author of "Teeth".

Welcome new Vice President Tracey Martin! She is replacing Marlana Thomas who took a position as a new faculty member at WVU! Good luck Marlana in your new endeavours!

VDHA Speaks Out Against Anti-Fluoridation Activity in Spotsylvania County

As dental hygienists, we are occasionally called to step out of our weekday professional roles and advocate for specific purposes or causes. We advocate for our profession, our patients and the public at large when we participate in the legislative process on Rally Day. VDHA supports dental hygienists as advocates for our profession and 'related issues'. In January, VDHA leadership was notified by ADHA of anti-water fluoridation activity in Spotsylvania County. As many of you are aware, over the past several years, anti-fluoridationists have surfaced around the country, including Virginia, to voice opposition to community water fluoridation (CWF). On January 23, the Spotsylvania County Board of Supervisors held a meeting to hear public comments on the pros and cons of water fluoridation, despite the fact that they have been fluoridating their water system for many years. The continuation of adding fluoride to the community water was being threatened because of one vocal person within that county who voiced concern about the safety of water fluoridation.

Upon hearing from ADHA, we notified local component members and <u>sent a letter</u> to each member of the Spotsylvania Board of Supervisors, clearly stating VDHA's position supporting water fluoridation. This was a great example of a coordinated effort by our national, state, and local level organization to mobilize members to advocate for a highly successful public health prevention strategy.

The Virginia Department of Health's (VDH) Community Water Fluoridation Coordinator, Jeanette Bowman, took the lead to spread the word about the need for, not only speakers, but for 'warm bodies' to attend this meeting. It was a shining moment for dental professionals, as there were approximately 20 people, mostly dentists and hygienists, who spoke in favor of continuing water fluoridation; and two people who spoke against continuation of the program. On behalf of VDHA, I spoke in support of the continuation of water fluoridation in Spotsylvania County. As of this submission date, there has been no official action taken.

If you hear of any similar opposition in your area, please don't hesitate to contact VDHA leadership for guidance. You are an expert in the prevention of dental caries, and can be an impactful voice to help educate local authorities with accurate, evidence based information.

# Virginia Dental Hygienists' Association Rally Day 2018

The Virginia General Assembly has relocated all legislative offices to the Pocahontas Building this year. The renovation did not stop the Virginia Dental Hygienists' Association from advocating for our profession. It simply called for us to renovate our own Rally Day. Instead of one large action day, it was reorganized to expand on our grassroots efforts within Virginia. Virginia Dental Hygienists' Association (VDHA) and the Virginia Dental Hygienists' Association Foundation offered "Teeth" by Mary Otto along with a fact card and talking points about Remote Supervision to each legislator.

Both VCU and ODU dental hygiene students were presented with an Advocacy lecture. This included lecture material on Virginia Dental Hygienists' Association's history on obtaining Remote Supervision,

legislative process, history of the Association's successful advocacy and a range of coalition activities engaged by the Association.

The Peninsula Component has personally distributed the books to their local legislators. They have been able to meet with the legislator and exchange words about remote supervision. It was nice to personally thank the legislators for their support of our previous legislation.

The Northern Virginia and Monticello Components will be attending the Capitol in February to deliver books to their legislators. They plan on making personal appointments while the legislators are in session to personally thank them for their efforts and support.

The Greater Richmond Component and VCU DH 2019 students attended a "mini-rally day" on January 26, 2018. They distributed books to both Richmond and Piedmont area legislators. It was a record year, in that we were able to have over half of the legislators speak with the students and dental hygienists! Both students and legislators appreciated the time together. The students felt fully prepared and took pride in distributing the books and explain the history of Remote Supervision.

With recent election changes and weather concerns, other components are still in the works on delivering the books. #### Words of Gratitude from Grant Recipient, Lindsey Bieligk, RDH

I thank the Virginia Dental Hygienists' Association Foundation for the generous grant I received to implement my public health program in November 2017. I was able to successfully execute four presentations to at risk title-1 elementary students in Fairfax Virginia. This program was targeted to the third grade students that can synthesize complex concepts of dental health, and several activities were included in the program that engaged students and reinforced the presence of dental hygienists in the community. I was able to successfully bridge the emerging dental hygienists from Northern Virginia Community College into the community of which they will practice within Fairfax County, and reinforce the roles of the dental hygienist beyond clinical dental hygiene. To complete the project, we used the funds from the Foundation to sponsor an original art coloring contest that could gauge the students level of synthesis following the presentation. Among the four schools I distributed awards in the form of gift cards to both GameStop and ToysRUs, which encouraged participation and improved learning outcomes. I was able to offer the prizes to the students thanks to the generous funding from the Foundation, which motivated students to pay attention and synthesize the information they obtained during the 30 minute presentation. This type of program would not be possible into this community without the generous support of the Virginia Dental Hygienists' Association Foundation and I look forward to the ability to reach out into the community again with the help of the foundation's grant allocated towards these important community programs.

# Lord Fairfax, Northern Virginia and Virginia Western Community Colleges



Second year students from Lord Fairfax, Northern Virginia, and Virginia Western Community College attended the Jane Weiner Dental Hygiene National Board Review course at Virginia Western Community College in December to jumpstart their studying for this comprehensive examination. The threat of a sudden winter ice storm resulted in moving the course from the College to Roanoke Memorial Hospital however, all students pleasantly adjusted to the change. It was a long, full weekend and the students left with an approach for studying and the realization that their dental hygiene educational programs had prepared them well.



## **Germanna Community College**

Germanna Update

The Spring 2018 semester launched on January 10<sup>th</sup>. There are currently 6 junior level students in the program. They are just beginning to treat patients at the Lloyd F. Moss Free Clinic. The students are super excited about their future careers and look forward to actually seeing and removing calculus.

Locally, the County of Spotsylvania has been having hearings to remove fluoride from the community water supply. Students have been able to witness these hearings and see the importance of local community professional involvement and testimony.

Dental hygiene students at GCC are now members of both ADHA as well as an interdisciplinary health council at the school. This council consists of members of all health professional programs taught at GCC. The council is in very infant stages and is adopting a bylaws. The goal is that by pooling resources and expertise, students will have more opportunities for service and learning at state and national levels.

GCC is pleased to report that for calendar year 2017, their partnership with the Lloyd F. Moss Free Clinic provided a little over \$625,000 worth of free care to the area.
