Our volunteer leaders have been sharing their time with me, inspiring and challenging me and it is life changing. In the past three months, we have accomplished A LOT to keep our Association "kite" rising up! I am so thankful for the volunteer leaders who dedicate their time and talents with me to improve the public's total health and advance the science and practice of dental hygiene.

In November, we went to work for this Association. The Leadership Services Council was created focusing on our leaders', our student members' and dental hygiene educators' development. In the middle of the month, our advocacy ad hoc committee was busy with lobbyists interviews and discussion on the interview. Our Administrative Council held a meeting to review calendar updates, established biweekly OMG meetings with the President and President-Elect, and finalized the OMG contract. I also invested my time in learning about the finances of this Association with our State Treasurer.



Congratulations goes to our Advocacy and Legislative Chair for our biggest win this month of bringing back our in-person Rally Day in Richmond, VA! The volunteers were gifted by Past President Emilie Ellis with royal purple scarves (thank you!). The sea of purple scarves showed legislators we are back and ready to work together to protect the public and advance the art and science of our profession.



An interview with Kristen Robbins, BSDH, RDH-President-Elect <u>fourkristen1992@gmail.com</u>

Legislative and Advocacy Committee

Greetings to all from your Legislative and Advocacy Chair,

We had a very successful Rally Day in Richmond on Friday, January 27. We had 19 Registered Dental Hygienists and 66 students from three Virginia Dental Hygiene programs: VCU, ODU and Virginia Peninsula Community College (formerly known as Thomas Nelson CC). We were divided into 15 groups with each of the hygienists mentoring and leading a group of students to visit with key committees: Health, Welfare and Institutes and the Education and Health Committees. We then went to see all of the legislators. We encouraged all students and RDHs to look up who their legislators are and communicate with them. We had talking points for all so that we delivered a united message. We also delivered oral health care kits to all legislators. Since we had no legislation that was being presented, the focus points of our "Talking Points" were as follows:

- Thanking our legislators for supporting the 30% increase in Medicaid reimbursements as it should increase the access to care by increasing the numbers of providers that are willing to work with the underserved populations.
- VDHA supports the concept of licensure portability as long as it upholds the same criteria that the BOD has outlined in the regulation 18VAC60-25-150, which defines the parameters for an applicant to be considered for "licensure by credentials".
- VDHA reminded the legislators to "look for the license" to be displayed when being cared for by a registered dental hygienist.
- We reminded our legislative representatives of the educational requirements that our profession requires of us to competently and safely serve the citizens of the Commonwealth of Virginia. Including our curricula of a minimum of 72-122 college credit hours depending on your degree (Associate or Baccalaureate), plus reminded that some hygienists hold a Master of Science and Doctoral degrees. We complete extensive hours of clinical practice to hone our skills to safely deliver care using instrumentation.
- For our license, we have to complete: a comprehensive written National Board, a state or regional clinical and written exam plus continue to take a minimum of 15 hours of continuing education to renew our license annually.

We felt these were important reminders for our legislators, as there are those who would like to consider having dental assistants perform coronal scaling. No legislation has been introduced, but it has been written about in the Virginia Dental Journal Vol 99 #4 October-December 2022.

Keeping the grassroots members informed and involved will help us to maintain the standards of care and the educational process for those of us who hold a dental hygiene license.
