Technology and the Dental Hygienist Susan Reid-Carr, RDH, BSDH VDHA President Elect 2014-2015

First of all Michelle and I would like to thank everyone involved for making our March Scientific Session a success. Westfields Hotel and Conference Center was excellent as were the speakers and courses that were provided. We appreciate the time, energy, and dedication it takes to provide our community with this opportunity.

As we seem to be speeding through the 21st century it's easy to feel left behind. A lot of us are using technology every day but I would like to address a few things that may not be used daily but can help hygienists stay connected in a busy world.

There are tools out there to facilitate online meetings. We can now share files and documents in one place and only those invited will have access to that information.

Social media and other platforms are places to share ideas and get crowd sourced answers to questions.

Many of our VDHA Council and Committee meetings now take place online. This frees up time at quarterly meetings and allows information to be gathered ahead of time for our Board meetings. These meetings may be useful to any hygienist who wants to meet with others and exchange information and ideas. There are many options but I want to encourage anyone interested to check out some options that are available. I have used www.anymeeting.com and found it easy to use. I have participated in www.gotomeeting.com and this also seemed work well. I have also participated in a meeting using www.webex.com this to me, was the least user friendly of the three. All of them offer free usage or free trials but to move up in services you will pay a fee. Based on research I have done AnyMeeting has the least restrictive use of free services.

Sharing files and documents is another way to stay connected and informed. Once again many options exist but I would like to share a few ideas. VDHA and GRDHA, where I share most of my information, use www.dropbox.com, which is probably the most widely used file sharing service. There is usually plenty of free storage space but you can pay for additional storage space. There are other services out there including www.copy.com and www.box.com, which I would encourage you to explore when looking for a file sharing service.

Last but maybe most familiar are social media and other communication platforms. Facebook Groups that can be set up through your homepage at www.Facebook.com provide a dedicated space where you can share updates, photos, or documents and message other group members. VDHA has a Facebook Group you can join. Listserv groups are informal groups connected by email to exchange ideas and have questions answered. Listserv groups require proper etiquette and realize that in an open group "anything could happen". ADHA has a number of listserv groups you may be interested in joining www.adha.org/adha-listserv. Another communication platform is Google Groups groups.google.com, it is similar to Facebook Groups so it can be a group preference choice. Wrapping up this section would be Skype www.skype.com. I communicate frequently using this platform. It can be used for voice messaging, text only real time messaging, or real time video messaging.

I hope I have shared something you might find new and useful for your technology tool kit. If we can make meetings, sharing of ideas and documents, and communication easier we will be "Better Together".
