Part of the reason that these meetings are successful is that the reconnection with friends from before as well as making new friends. Hygienists are the best!



Finally, in November our winter social was held at a local restaurant to celebrate the year and the upcoming holiday season. Several door prizes were given away and everyone enjoyed mingling.


