# **VDHA LIASON ATTENDS MINI MOM**

VDHA member, Trish Bonwell, volunteered her time at a Mini Mom Project, "Give Seniors a Smile", held at Envoy of Westover Hills on June 20, 2014. Trish states, "The project provided me an opportunity to collaborate with a great group of people as we all worked toward the goal of improving oral health care for members of a long term care facility. Dental hygienists play an important role in preventative care for this population. This is an underserved population whose access to oral health care must be improved. Through a collaborative approach to the provision of oral health care, positive changes can be implemented that will benefit not just oral health, but overall health and quality of life for residents of long term care facilities."

Some stats from the event are provided below.

20 volunteers (7 dentists, 2 RDHs, 2 assistants, 1 dental student and 8 volunteers)

52 patients

47 exams performed

6 cleanings/gross debridements

4 extractions completed on-site

6 denture relines completed on-site

Goody bags with toothbrush, tooth paste and floss to all residents (~170)

Referrals: Residents needing further oral-care treatment will be coordinated with VDA dentists.

She hopes this project will serve as a start in developing a model, which dental hygienists will be greatly involved, for improving the provision of oral health care to residents in long term care facilities.

# Statement in Support of Community Water Fluoridation Virginia Dental Hygienists' Association

This letter is in response to the Costco Connection June 2014 article, "Should Community Drinking Water Be Fluoridated?" The Virginia Dental Hygienists' Association (VDHA) supports community water fluoridation as a safe and effective public health strategy to prevent tooth decay in children and adults. VDHA policy advocates evidence-based practice modalities, including fluoride therapies, for the prevention of disease for the public that we serve. The American Dental Hygienists' Association supports education of the public and other health professionals regarding the preventive and therapeutic benefits of fluoride.

In Virginia, more than 5.8 million citizens consume water that has been adjusted with fluoride to the optimal level. Optimal level standards are set by the Environmental Protection Agency under the federal Safe Drinking Water Act. The Virginia Board of Health recommends that all public water systems in Virginia be optimally fluoridated. (1)

Fluoride, both systemic and topical, is a well-known preventive strategy to prevent tooth decay. It is shown to prevent the formation of cavities, slow the progression of cavities, and reverse the progression of the initial stages of cavity formation. Fluoridated water provides added protection against tooth decay in children, despite the widespread use of fluoride toothpaste. (2) (3). It is the most effective public health measure to prevent costly tooth decay, resulting in up to a 40% reduction in decay rates.

The most effective way to reduce the gap in tooth decay rates between income groups is water fluoridation. Water fluoridation benefits children and adults regardless of income level or insurance status. (4) Additionally, the cost savings on future dental care are significant. For every \$1 spent on water fluoridation, \$38 is saved in dental treatment costs. (5)

Claims of potential toxicity from fluoridated water have not been supported by studies of scientific merit. (6)

VDHA appreciates the opportunity to comment on this very important topic.

# **VhyPAC Report**

At the fall HOD we had a silent auction with items donated by components: \$793.00. We had members join the PAC in the fall: \$335. In the spring at our Scientific Session we held our basket auction: \$824.00. With component donations and individual memberships we have raised another: \$735. Components (01, 06, 07 and 09) have contributed a combined effort of \$3165. So our yearly fund raising ended with a balance of over \$5000. This is a very good year, however, Ralston King, our lobbyist, has challenged us to double our contributions this year.

This means our PAC is challenged to raise another \$5000 by October 1<sup>st</sup>, 2014. This can only be met if we have all components take part in the fund-raising. A good ballpark figure per component is to take the membership number and multiply it by \$25( fee to belong to the PAC). We can do this and I am counting on all of you to help to make it happen!

In the fall at our HOD, September 25-27, 2014 at the Sheraton Park in Richmond, VA, we will hold a silent auction with donations from all components. It will be the new calendar year for becoming a member of the VHyPAC. I look forward to seeing you and having you join us! We will kick off our yearlong raffle of a beautiful handsewn quilt donated by member, Meg LeMaster. We will sell tickets at the HOD and online from our website and Facebook page. All legislative chairs will have tickets to sell at their component meetings too.
