Public Health, Education & Professional Affairs Council News

The Virginia Dental Hygienists Association (VDHA) recently submitted a letter to the Board of Dentistry in support of adding to the permitted duties of a dentist and dental hygienist the ability to perform the necessary screening tests to identify those at risk for diabetes. A CDT code already exists for this testing and many other states have language that permits such testing in dental offices. VDA has submitted a letter in support of this testing by dentists and dental hygienists as well.

VDHA also spoke in support of Department of Health Professions Director Dr. Brown to amend the Board of Dentistry legislative proposal to the Governor to add "or remote" supervision to \$54.1-3408(J) and to add the Schedule VI topical drugs (which includes topical fluorides) addressed in \$54.1-3408(J) to \$54.1-2722 F (g).

VDHA FOUNDATION SUCCESS

Each year the Virginia Dental Hygienists' Association Foundation funds two student delegates from all nine DH school's senior classes to attend the VDHA House of Delegates (HOD). This funding includes registration, meals and lodging. These student delegates are selected by their faculty.

Success story: Five of the 2017 HOD student delegates attended our recent 2018 HOD as full delegates. We took this opportunity to ask what factors motivated these recent graduates to join VDHA and become active in their component and VDHA.

The following are the questions and their written responses.

Q. Did your experience as a student delegate last year impact your decision to serve as a delegate from your component this year?

A. Absolutely! My experience as a student delegate had a huge impact on my willingness to be a part of the revival for component 05. It gave me insight into the realm of the VDHA and what it is all about. It made me realize that in order to stay passionate, I have to stay involved.
