



# **Adult Dental Benefit Update**

The great news is that comprehensive dental benefits for all Medicaid enrollees was included as a budget amendment in the final budget from the 2020 General Assembly legislative session. However, because of the unfortunate and extraordinary economic impact on the state due to COVID19, Governor Northam has suspended all new spending until the legislators convene again this summer. The PHEPA Council extends a huge thank you to all who advocated for this benefit, as part of our partnership with the Virginia Health Catalyst. Our message was heard and had an impact! We will keep you informed as events unfold over the next few months



# **Board of Dentistry License Renewal Update**

The PROPOSED CHANGE TO LICENSE RENEWAL IN BIRTH MONTHS is in the final stage of the promulgation process. The proposal also includes tracking annual continuing education requirements by birth month. The Board anticipates changing the renewal schedule in 2021. To implement the transition, renewal fees will be prorated based on the number of months it will take from March 31, 2021 to each licensee's birth month in 2022. For example, a licensee born in January will renew in March of 2021 and his license will come up for renewal in January of 2022 while a licensee born in October will also renew in March 2021 and his license will come up for renewal in October 2022. This year ADHA IOH has once again divided up the year into Autumn Giving Campaign from July 1st through December 31st and the 2020 ADHA IOH National Fundraising Campaign, which was launched January 15, 2020 in tandem with the ADHA 97th Annual Conference & Business Meeting Registration, launch date. Unfortunately, we won't be "LIVE" at the ADHA Annual Conference in New Orleans but we still hope to meet our IOH goal!

Our VDHA assigned goal for 2019-20 is \$8,752 and we have now raised \$3,927 to date. The money raised through the Lynch Creek Fundraising site has still not come into the VDHA treasury but will be sent to ADHA as soon as it does so. It was only \$65 this year but will gain traction as a nice adjunct to our fundraising efforts due their beautiful product line. Many thanks to all of you who have already donated to IOH! 
 We supported the GCC Dental Assisting program by participating with set up and break down at their graduation ceremony.
