## Regulation and Practice Committee

It is that time a year again when member of the House of Delegates are up for re-election in November. VDHA has reaped the benefits of many years of political involvement from getting to know the legislators. I know that for many members this puts you way out of your comfort zones, and it is ok to explore areas where we are uncomfortable. I continue to chair the Regulation and Practice Committee, (formerly known as the Legislative Committee) because I believe so strongly in our political process. When I was first chair of the Northern Virginia Component in the mid 1990's I only dreamed that Virginia dental hygienists would have general supervision, much less be able to administer local anesthesia and nitrous oxide. It was through many uncomfortable meetings and gatherings that I became more comfortable and felt my voice would be heard. It was not only my voice, however. These efforts take many voices to make that message loud and clear.

I had the privilege to attend the ADHA Lobby Day on Capitol Hill with several members of VDHA. The inspiration that came from being there was overwhelming. Hearing how the death of a young Maryland youth has created awareness among our Representatives in Congress - words cannot explain. It is time for the voice of oral health to be heard. It takes the hands and efforts of many for the work to come to fruition. So while components are preparing their fall events, consider inviting your local legislators to a component meeting as well as the challenger of the local race. With these meetings dental hygienists in the Commonwealth can assure that our voice will be heard collectively and that we have a place in improving the oral health of all Virginians.

Get involved by meeting with the candidates and helping with their campaigns. This is as easy as stuffing envelopes, walking around the neighborhood or hosting a meet and greet. Your component leadership and regulation and practice chair are available to answer questions as well.

Current Issues the Regulation and Practice Committee is monitoring:

DAII – Members are still monitoring the progress of the Board of Dentistry regarding the duties that will be delegated to the DA II and DA I. As of this writing there have been discussions with members present as well as our legislative consultants. We will continue our vigilance in all areas of the regulatory and legislative process in keeping members informed with the help of our legislative consultants.

A major victory for citizens of the Commonwealth is the signing of HB 2180 and SB1202. The summary is given below.

**Summary:** Provides that a dental hygienist who holds a license or permit issued by the Board of Dentistry may provide educational and preventative dental care in the Lenowisco, Cumberland Plateau, and Southside Health Districts, which are designated as Virginia Dental Health Professional Shortage Areas by the Department of Health, and that any dental hygienist providing such services shall practice pursuant to a protocol developed by the Department of Health. The medical directors of the three health districts shall submit a report of the services provided by the dental hygienists to the Secretary of Health and Human Resources by November 1, 2010.

Currently this committee is working together so that these underserved areas may now have access to an oral health provider through the department of health. It is an exciting time to be a dental hygienist!

**Mega Issues Forum Workshop:** ADHA leadership discussed the backgrounder issues among the table, and discussed potential solutions among the group for work force related issues.

**Meeting with Stacey Chappel:** Discussed current legislative challenges and opportunities within Virginia and received a legislative workshop toolkit.

#### **"Growing Your Membership Online: MySpace, FaceBook and YouTube for Newbies"**

The idea is to utilize the Web 2.0 such as MySpace, FaceBook, YouTube and Twitter because of the exposure it encompasses. You can also have "list serve" which is a mass email correspondence. YouTube has 20,000 views a day and Twitter is second to YouTube for views. Social networking is popular because people feel more connected. This is an enhanced marketing possibility since people communicate this way. 70% of people between the ages of 15-35 communicate via Web 2.0 technology.

**Organizing and Integrating Effective Public Health Efforts:** this session offered participants an overview of evidence-based steps for organizing public health efforts within the community while focusing on the Essential Public Health Services to mobilize partnerships and integrate oral health into existing, sustainable programs. Multi-disciplinary approaches for expanding health promotion and disease prevention throughout the integration of oral health content were showcased.

#### **ADA Commission on Dental Accreditation Hearing**

The Commission on Dental Accreditation conducted an open hearing during the ADHA Annual Session. The purpose of the hearing was to provide the dental hygiene community with an opportunity to comment on the proposed revisions to the Accreditation Standards for Dental Hygiene Education Programs.

**Town Hall Forums:** Attended Town Hall forums to discuss proposed policy and bylaw changes.

#### **Report of Minutes from ADHA HOD**

#### **Proposed Resolution 1**

White paper: An authoritative report or guide that provides information about emerging knowledge and issues on a specific topic.

There being a majority in the affirmative, PR-1 was **adopted as amended**.

Report of 86<sup>th</sup> ADHA Annual Session, 2009**Proposed Resolution 2**

Fact Sheet: A document that summarizes key points of information for distribution.  
There being a majority in the affirmative, PR-2 was **adopted as amended**.

**Proposed Resolution 3**

Dental Home: A relationship between a person and a specific team of health professionals, led by a licensed dental provider. The dental home is an ongoing partnership that coordinates comprehensive, accessible and culturally sensitive care through delivery of oral health services as part of integrated health care.  
There being a majority affirmative, PR-3 was **adopted as amended**.

**Proposed Resolution 4**

ADHA supports the administration/delivery of preventive and therapeutic procedures as outlined in the dental hygiene scope of practice by licensed personnel only: specifically, those who have graduated from a CODA accredited dental hygiene program and who have successfully completed and maintained all state licensing requirements.  
There being less than a majority in the affirmative, PR-4 was **lost**.

**Proposed Resolution 5**

That Ethics 3-94 which reads:

The American Dental Hygienists' Association opposes any misrepresentation of dental hygiene services.  
Be rescinded.

There being less than a majority in the affirmative, PR-5 was **lost**.

**Proposed Resolution 6**

ADHA advocates that the dental hygiene diagnosis is a necessary and intrinsic element of dental hygiene education and scope of practice.  
There being a majority in the affirmative, PR-6 was **adopted**.

**Proposed Resolution 7**

That Public Health 5-07 which reads:

The American Dental Hygienists' Association supports the role of state based health-related coalitions.  
Be rescinded.

There being a majority in the affirmative, PR-7 was **adopted**. **Proposed Resolution 7S**

That Public Health 33-93/27-74 be amended to read:

The American Dental Hygienists' Association affirms its support for optimal oral health for all people and is committed to collaborative partnerships and coalitions that improve access to oral health services. There being a majority in the affirmative, PR-7S was **adopted**.

**Proposed Resolution 8**

That Public Health 6-99/25-92 be amended to read:

The American Dental Hygienists' Association supports comprehensive oral health programs and services that reach at-risk populations.

There being a majority in the affirmative, PR-8 was **adopted as amended**.

**Proposed Resolution 9**

That ADHA amend Access 30-92 to read:

The American Dental Hygienists' Association advocates that any health insurance program include benefits for preventive, restorative and therapeutic oral health care.

There being a majority in the affirmative, PR-9 was **adopted**.

**Proposed Resolution 10**

That Access 6-03 is amended to read:

The American Dental Hygienists' Association supports expanding access to preventive, restorative and therapeutic care within the dental hygiene scope of practice.

There being a majority in the affirmative, PR-10 was **adopted**.



**Proposed Resolution 11**

That, Access 14-00/28S-92 be amended to read:

The American Dental Hygienists' Association advocates that state dental hygiene and/or dental practice acts be amended so that the services of dental hygienists who are graduates from an accredited dental hygiene program can be fully utilized in all public and private settings.

There being a majority in the affirmative, PR-11 was **adopted**.

**Proposed Resolution 12**

That, Access 7-99/16-85 be amended to read:

The American Dental Hygienists' Association supports the following:

1. Interdisciplinary care that focuses on prevention for those who are developmentally, physically, mentally and/or medically compromised.
2. Promotion of public and professional awareness of the need for care.
3. The encouragement of public funding, where appropriate, and third party payment for such services.

There being a majority in the affirmative, PR-12 was **referred**. The delegates requested that a definition of *interdisciplinary care* be developed for consideration by the 2010 House of Delegates.

**Proposed Resolution 13**

That Government 1B-08 be amended to read:

ADHA supports Dental Hygienists as advocates for the profession of dental hygiene and related issues.

There being a majority in the affirmative, PR-13 was **adopted**.

**Proposed Bylaws Amendment 1**

That the revised bylaws be adopted.

There being a strong two-thirds majority in the affirmative, PBY-1 was **adopted**.

**Proposed Resolution 4S**

The American Dental Hygienists' Association supports oral health care workforce models that culminate in:

Graduation from an accredited institution

Professional licensure

Direct access to patient care

The speaker declared PR-4S **adopted unanimously**.
