# Spring 2010 Dental Hygiene Symposia



Management of the Oncology and Terminally III Patient

Friday, February 19, 2010, 9am – 1pm, Fredericksburg Campus, HLTH 2262-21, Tuition: \$50

In this four hour continuing education course, participants explore the special niche for the dental community in the area of caring for patients undergoing cancer treatment. Topics include radiation and chemotherapeutic treatments and implications for dental care. Oral and palliative care for the terminally ill will be covered as well. Participants will understand the importance of oral health and the role of dentistry during the end stages of life.

Presenter: Bettina Gigliello, RDH, BSDH Ms. Gigliello graduated from the University of Missouri, Kansas City, School of Dentistry with at BS in Dental Hygiene in May 2000. During her studies at UMKC, she participated in the Oncology and Special Patient Care Program. She studied the dental hygiene implications of cancer therapy, obtaining a certificate of service from the American Cancer Society. Ms. Gigliello created the HospiceCare of West Virginia program. The goal of the HospiceCare program was to increase patient comfort during the end stages of life. The program dealt with the oral hygiene needs of hospice patients, educated nursing staff, and in coordination with local physicians established a palliative oral care program for hospice. Ms. Gigliello has 10 years of clinical practice in general dentistry and periodontics. She is currently employed as an adjunct faculty member for the Northern Virginia/Germanna Community College Dental Hygiene program. Mrs. Gigliello serves as Corresponding Secretary for the Virginia Dental Hygienists' Association. She was most recently elected Vice President of the Fredericksburg Dental Hygienists' Association.

Identification and Management of Medical Emergencies, Risk Management, and Documentation

Saturday, March 20, 2010, 9am – 1pm, Fredericksburg Campus, HLTH 2263-21, Tuition: \$50

While medical emergencies don't happen frequently, when they do it is essential that practitioners be well-versed and comfortable in handling them. In this four hour continuing education course participants will refresh their minds on the signs, symptoms, and treatment of medical emergencies. Topics include risk management and documentation.

Presenter: Dr. Darryl Pirok: Dr. Darryl Pirok graduated from the University of Illinois, College of Dentistry in 1964 and completed his Anesthesia and Basic Science training at the University of Pittsburgh. His Oral and Maxillofacial Surgery training was completed at Henry Ford Hospital Heath Systems in Detroit, Michigan. He has maintained a private oral surgery practice for the past 30 years here in Va. and previously in Chicago. In addition to private practice, Dr. Pirok has been involved with both academic and hospital centers, having an interest in dental anesthesiology. Prior to moving to Virginia, he had an academic affiliation with Rush Medical Center in Chicago and directed a dental general practice residency program. He continued his ove of teaching in Virginia with a full time faculty appointment at Virginia Commonwealth University School of Dentistry from 1975-1977 and is currently adjunct clinical professor of oral surgery at the VCU Dental School. He has served on numerous boards including the Virginia Board of Dentistry and at present sits on the Board of the Northern Neck Free Health Clinic and the Virginia Association of Free Health Clinics.
