GOVERNMENTAL AND PROFESSIONAL AFFAIRS COUNCIL UPDATE

Lobbyist Hilton Graham has suggested that most of our efforts in the coming months be directed at the NOIRA review that the Board of Dentistry will be conducting involving regulatory changes for dentists, dental hygienists and dental assistants. He has asked for an estimated number of dental hygienists who are currently unemployed or under employed at this time, especially new graduates. Kara Davis has put this question out on Facebook and all members are encouraged to register as "friends" of the Virginia Dental Hygienist's Association and respond so that we can start acquiring these numbers.

The regulations for Dental Assistant II are still on the governor's desk waiting to be signed. A letter was hand carried by our lobbyist expressing the concern of VDHA that we are being grouped together with the DAII throughout the proposal instead of recognizing the differences in educational background, regulation and clinical expertise.

Medicaid provider status is also on the agenda to try and attain in the near future. Dr. Rita Sheaves is working on "Talking Points" that can be used at Rally Day and when contacting the Department of Health with our request. This status would be beneficial when accessing care to more of the indigent populations.

Rally Day will be held two days in January 2011 to allow access for more dental hygiene students to attend. Tuesday, January 18 and Friday, January 21 will be the regularly scheduled days with Jan 25 and Jan 28 as back up days in case of bad weather. Items for the legislative bags were distributed at the last meeting and we hope to see another good turn out of students and experienced members to help hand them out to senators and delegates at the General Assembly.

Vhy-Pac will be doing a silent auction again at annual session to raise funds for our lobbyist. A 50/50 raffle is being held at VDHA Executive Board meetings and components are encouraged to find creative ways to raise funds at their regular monthly meetings. This is a big year for legislative changes and we need extra funds to make sure that our voice is being heard!

Adopt a Head Start

In 2006, Component 02 (Greater Richmond) adopted the Chesterfield County Head Start program, which served as the pilot for the statewide partnership between VDHA, Virginia Head Start, and Virginia Department of Health.

Since then 8 components have been trained through the Virginia Department of Health Dental Health Program; and 10 Head Start programs have been adopted by ~15 individual hygienists and 2 dental hygiene schools (ODU and Germanna). Many thanks to all of you who have donated your time and expertise to these programs.

The 2-hour CE trainings are still available to any component who has not been trained or needs a 'refresher'. The course prepares you to provide educational programs as well as serve on the local Head Start advisory committee as a dental health representative. If your component has been trained but needs some 'technical assistance', that is available also.

Through this partnership, we have been successful at bringing hygienists 'to the table' in several ways. Not only have we improved Head Start's access to important education and preventive measures on the local level, but we now have VDHA representation on the Virginia Head Start Health Advisory Committee, with Lesa Crane as our representative.

THE CHALLENGE:

This year I would like to challenge each component to provide at least ONE parent oral health session for a local Head Start. I have 'user-friendly' resources that make this very easy. A parent session usually lasts about 20 – 30 minutes, depending on the local program format.

This is your opportunity to share your much-needed knowledge with parents who may not get these messages simply because they cannot afford to take their child to the dentist.

Dues Increase Scheduled for 2011/2012

As a result of recommendations outlined in the Lang Report, the Board of Trustees, at their September 2009 meeting, directed that ADHA increase national dues from \$170 to \$175 (3%) beginning January 2012 with a subsequent yearly cost of living increase of 3% to be re-evaluated every three years beginning in 2015.

The biggest reason for the dues increase is because of the cost of inflation in the last decade. The cost of ADHA to continue to do business and offer the benefits that they do continues to rise. ADHA is effectively trying to pay for more and more with less and less. Also, traditional sources of non-dues revenue for associations are declining across the board. They can no longer count on affinity royalty programs, investment income or advertising revenue in a tumultuous economy.

The increase will be effective starting with the 2011/2012 winter cycle. Dues notices going out in October 2011 will reflect this increase as will dues notices going out in the 2012 summer cycle.

Gearing up for Winter Cycle 2011

Winter Cycle 2011 is just around the corner and ADHA has some very exciting plans as they move into the New Year. Beginning in October ADHA will start to roll out a new communication strategy for renewing members. This new approach will be modeled after the existing personalized communications used in their renewal efforts over the past 2 years. The goal with this new strategy is to feature new content to further engage our members and encourage membership renewal.

In Mid-October ADHA will begin electronic communications to renewing members. They will again encourage online renewal by offering anyone who renews online a chance to win a pair of Orascoptic Loupes. Any member who renews online as an annual or who enrolls in the Quarterly Payment Plan (QPP) before December 31st will be eligible to win!

Reminder any member wishing to transition from an annual member to the QPP must do so before December 31st.

In order to further ADHA's efforts of "going green" they will be reaching out to any member who renewed their dues online last year and encouraging them to sign up for ADHA's new automatic annual renewal program. ADHA hopes to have significant participation from this group of members and hopes to reduce the number of hard copy invoices that they send out.

Opportunity, Adventure, and Purpose: A Summer Internship with The Indian Health Service



This summer, I had the invaluable opportunity to experience an exceptional and rewarding internship through the Indian Health Service. My 1,300-mile trip from Richmond, VA landed me in the Oklahoma City suburb of El Reno, Oklahoma. El Reno lies 20 miles west of Oklahoma City and is a part of the Cheyenne – Arapaho Nation. The city is located at the intersection of two historic highways, nostalgic Route 66 and the Chisolm Trail (Highway 81), in the heart of the Canadian Valley.

The EI Reno Indian Health Center includes medical, dental, optometry, public health nursing, podiatry, pharmacy, pediatrics, and behavioral health services. The dental clinic's staff includes 2 dentists, 2 assistants and 1 dental hygienist position. The clinic provides emergency services, general dentistry, pediatrics, simple extractions, and non-complex endodontic therapy. While in El Reno, I had the opportunity to

see a distinctive population with diverse and critical oral health needs. Some patient needs included quadrant scaling and root planing, multiple visits, extensive OHI sessions, and information on systemic diseases and nutritional habits. While assigned, I had an opportunity to see a patient with squamous cell carcinoma, calculus bridges, Class III mobility and shadow the dentist during some local anesthesia injections. Majority of the population seen in this clinic were diabetic, had high blood pressure, or both. Many had severe signs of bruxism and multiple missing teeth. Since I had spent the past 9 years as an Air Force dental technician, I was familiar with many of the policies and procedures in the clinic. So, I was able to help out in other areas of the clinic, as well. On my first day of reporting to the EI Reno dental clinic, I helped the assistant with sterilization, radiology, assisting, and was soon able to answer questions from patients over the phone. The clinic is equipped with digital radiography, nitrous oxide, and a mini laboratory. Since my leaving, the clinic has began renovations to include new up-to-date chairs.

Overall, this rewarding experience allowed me to grow both personally and professionally. The dentists and staff at the El Reno Indian Health Clinic were always welcoming and open to help. I was mentored by an experienced Commissioned Corps officer of 18 years, Dr. James Palerino, DDS who provided me with experiences and lessons that have built a foundation for my future in dentistry. He not only enlightened me in terms of the dental field and profession, but offered a wealth of information in reference to career avenues as a Commissioned Officer in the Public Health Service. He helped me to realize the importance of the dental hygienist as a



member of the oral health care team. This internship allowed me to gain invaluable networking connections, mentors, and lasting relationships with professionals throughout dentistry.

Being a summer intern at the EI Reno dental clinic allowed me to experience the rich Native American culture of the Cheyenne-Arapaho Nation. I had the opportunity to view the reservation, ate my first Indian taco, visited Bricktown, and enjoyed learning about the different native cultures. This experience has provided a great building block for my interest in public health. It was an amazing travel, clinical and cultural experience. Truly, the Indian Health Service's mission of opportunity, adventure, and purpose was evident in the daily activities of my internship at the EI Reno Indian Health Clinic and in Oklahoma this summer.

The week of June 22-27, I was afforded the opportunity to attend ADHA's CLL Annual Session in Las Vegas, NV. While at annual session, I attended ADHA's community service day, student track sessions and activities, and Exhibit Hall. I and three other hygiene

students from Virginia Commonwealth University spent the week gaining knowledge, personal experience from other students and hygienists, and taking advantage of mentorship and networking opportunities. Whether I am presiding over and interacting with my peers and the community during SCADHA, sitting in on and getting experience with GRDHA component involvement, or becoming re-energized and gaining continual education through ADHA's annual session, the first year of my dental hygiene journey has been truly remarkable!
