

Greetings and Happy New Year,

The New Year has begun and it comes with many opportunities to get involved in component, state and national events. VDHA worked hard to prepare for Rally Day 2015 on January 30<sup>th</sup> and helped support continued dental benefits for pregnant women. We hope you will join us for the VDHA Spring Scientific Session March 12-15 to network and take advantage of the wonderful continuing education offerings and mark your calendars for the ADHA Annual Session in Nashville June 17-23. Don't forget to take advantage of the programs and events offered by your local components.

The VDHA continues to stay abreast of the professional landscape and best ways to meet the oral health care needs of our communities. Your leadership has been actively monitoring legislative actions, participating on task forces and in meetings with other stakeholders to represent the interests of VDHA and improving oral health. It is important, as professionals, you stay attuned to matters of importance to the practice of dental hygiene.

In August, the Healthcare Workforce Data Center published the latest data on the dental hygiene workforce in the Commonwealth. The report had an 84% response rate from the 5563 license holders in the Commonwealth. The report noted 54% of hygienists have an Associate Degree and 41% have a Baccalaureate Degree. The survey revealed a 93% satisfaction rate with current employment, 91% of respondents holding a license are currently working and an average income between \$50K-60K. In 2012 the Joint Commission on Health Care (JCHC) was tasked to conduct a two- year study on dental safety net capacity and opportunities for improving oral health. Members of VDHA provided input at these meetings to inform JCHC members on the current RDH scope

of practice and our role as vital member of the health care team. The JCHC received comment from many stakeholders and compiled seven options to improve oral health care in the Commonwealth. Options included take no action, four different types of budget amendments, to evaluate tele-dentistry and the expansion of remote supervision. We applaud JCHC for their time and effort on this important issue. On November 5, 2014 the Board voted on the seven options unfortunately, Option 1- Take No Action, was approved by a vote of 14-3. The latest movement in oral health care delivery has been the draft document, *Review of Dental Hygienist Scope of Practice* by the Virginia Board of Health Professions (VBHP). The VBHP advises the Governor and general assembly on matters related to regulation and deregulation of health professions and scope of practice issues. To address the implementation of the Affordable Care Act, the VBHP reviewed the scope of practice and regulation of dental hygienist in Virginia. They compared dental hygiene with related occupations in other states and examined the protocol and success of the current Virginia Department of Health remote supervision dental hygienist. The impetus of the draft is to determine if different models of dental hygiene regulation could be less restrictive, adequately protect the public and lessen the economic impact of regulation. The board compiled six policy options that are currently being reviewed. The VDHA offered public comment on January 22 and written comment is available until February 10<sup>th</sup>.
